India Ratings and Research (Ind-Ra) has assigned Shrem Infra Structure Private Limited's (SISPL) facilities the following rating:

^The ratings on the proposed PP MLDs are provisional and pending execution of documents as detailed in Annexure I. The final ratings, upon receipt of executed documents consistent with the draft documents, shall be assigned within 90 days from the date of issuance of the instrument. The provisional ratings may be extended by another 90 days, subject to Ind-Ra's policy, if the execution of the documents is pending.
